CERTIFICATION

In 1987, the National Association of Division Order Analysts achieved a major goal of the organization through the inception of its Voluntary Certification Program policy. The objective of the policy is to enhance and strengthen the professional status of the Division Order Analyst. For individuals who attain the designation of Certified Division Order Analyst (CDOA) the policy provides a standard by which the industry, public, and other official groups can recognize that those individuals have attained a high level of Division Order experience, knowledge and professional competency.

Certification is available to all eligible Division Order Analysts that are NADOA members. To be eligible for certification, one must have a minimum of five (5) years Division Order experience (2 years may be substituted by a college degree) and be currently employed in that work or a related position. After application for certification has been approved, the individual's technical competence will be tested by a written examination based on material contained in the CDOA Review Manual.
